This addendum is to give notice for the following:

Below are answers to a number of questions posted by multiple prospective vendors (financial institutions)

1. For the cove base items (2200201-2200205) is the quantity in cases (120 linear feet) or pieces (4 linear feet). Also 205 specifies a toe on the base, are 201-204 toeless?
 - **The Est Qty 201-205 are pieces (4-linear feet) & they are also All Toe Base**
2. For items 2200301 & 2200302 there is no pattern specified, and the material should be either rubber or vinyl (it can't be both). Common patterns in the round nose are smooth, ribbed, diamond or circle.
 - **Vinyl-Smooth**
3. All the companies I have talked to sell cove adhesive in 30oz tubes rather than quarts, would this be an acceptable substitution?
 - **Substitute in Brand or in size? If you mean the Brand there is no Substitution the Dap we carry comes in 32oz.**
4. Are there any products you are not accepting substitutions on?
 - **No Substitution on this contract.**

Also, enclosed are the IFB results, containing specific pricing/fee structure, from the last bid solicitation.

All other terms and conditions of this solicitation remain unchanged.
